# Bois Locker Room:

The group, "Bois Locker Room", is believed to comprise young schoolboys in the capital, Delhi.

Screenshots of chats on the group have been shared widely on social media.

The incident has caused outrage in Delhi, which is already seen as one of India's most unsafe cities for women.

Several Instagram users who had been made aware of its existence began posting about the group and calling out members for their behaviour.

It turned out that members were sharing images of their classmates and other underage girls without their knowledge or consent along with crude comments ranging from body shaming to jokes on sexual assault and rape.

The screenshots began to be widely shared on WhatsApp as well as Twitter and other social media platforms.

But Shubham Singh, a cyber expert who works closely with law enforcement and was one of the first people to begin investigating the group, has cautioned that many of these screenshots look edited.

He added that there appeared to be a mix of images from this group and some similar groups that exist on other social media platforms like Snapchat.

He said he started looking into the group after some Instagram users got in touch with him and sent him screenshots.

"I tried to investigate it properly but no-one was coming forward to file a complaint. So we tried to find out who was behind the group. They had deleted their Instagram accounts but through the screenshots and some tools, I was able to trace them," he said.

Mr Singh then passed on the information to the police, which has now led to one teenager being taken into custody. <sup>3</sup>

Twitter of an online group called "Bois Locker Room".

They show members of the group - said to be Class 11 and 12 students from some of Delhi's top schools - posting photos of teenage girls without their consent along with comments too crude to be reproduced.

A number of conversations purportedly showed members talking about sexual assault often against their own classmates, raising questions about normalising of rape, misogyny and objectification in schools.

Leaked screenshots showed rape threats on the group. The allegations triggered outrage on social media with the top trending hashtag #BoysLockerRoom amassing thousands of posts on Twitter and other platforms.

The Delhi Commission for Women Chairperson Swati Maliwal called for the arrest of those associated with the group.

"The DCW has sent notices to Instagram and Delhi Police. We want these boys to be arrested immediately and the strongest action to be taken against them," she told NDTV.<sup>4</sup>

#### **Kolkata Rape Case:**

Tens of thousands of women in West Bengal state marched through the streets on Wednesday night in protest against the rape and murder of a trainee doctor at a state-run hospital in Kolkata last week.

The Reclaim the Night march was the culmination of nearly a week of frenzied protests ignited by the brutal killing of the 31-year-old at the RG Kar Medical College last Friday. <sup>5</sup>

There should not be strict regulations on social media platforms like Instagram.


#### **Limitations:**


Do you follow the community guidelines of Instagram? 64 responses



Have you been a victim of abuse on Instagram by someone?




Do you think there should be a age limit on Instagram? 64 responses


Who do you think misuses Instagram the most (age group) 64 responses




